The Barnett Reservoir Foundation will provide a limited amount of portable bathrooms to the public and teams throughout Old Trace Park. Teams that desire their own units — or to share with another team) may purchase them through us at \$100 per unit. Deadline for reserving one is Sept. 1.

**Cleaning Deposit (Required of all teams): \$50.**

Old Trace Park is a public park and sits on the edge of Barnett Reservoir, which is the primary water source for the City of Jackson MS. The Park must open to the public the day after the BBQ. The \$50 deposit will be returned to teams — WE DO NOT WANT THE MONEY — once your cooking site is certified as acceptably clean by one of our tournament committee members. **All wastewater must be removed from the park or dumped into one of the holding tanks provided in the competition areas.** If a team is found violating wastewater or trash rules, it will be disqualified, and its entry fees/deposits forfeited.
